

Mirror Limited Warranty



United Plate Glass Company (UPG) warrants its standard mirror products for five (5) years after the date of manufacture against manufacturing defects resulting in deterioration of the silver film which substantively affects or obstructs the mirror image in the vision area, due to faulty manufacturing by UPG.

Liability under this Warranty for a defective mirror is limited, at UPG's sole option, to either replace such mirror without charge to the original purchaser or, to refund 100% of UPG's original selling price for such mirror. The replacement mirror will be covered by the same exclusive, limited warranty, but only for the balance of the original warranty period. UPG reserves the right to inspect any allegedly defective mirror prior to its removal from the installation location. UPG reserves the right to reject any claims. **LABOR COSTS ARE NOT COVERED BY THIS WARRANTY.**

CONDITIONS WHICH WILL VOID THIS WARRANTY:

UPG will have no liability under this Warranty if any of the following events have occurred: **(a) the Mirror is cracked, chipped, or broken; (b) the Mirror coating is attacked by incompatible or corrosive chemical agents such as cleaning fluids, solvents, sealants, adhesives, chemical fumes, etc; (c) the Mirror is subjected to standing water or other liquid; (d) the Mirror has been installed or used in an application other than indoors; (e) the Mirror is damaged or altered by handling, storage, or installation contrary to standard industry practices as referenced by the Glass Association of North America; (f) the Mirror is installed in a high moisture environment, including but not limited to swimming pool enclosures, greenhouses and bath enclosures; (g) the Mirror was discarded or destroyed before reasonable opportunity for inspection by UPG.**

The glass is supplied by mirror manufacturers in compliance with ASTM C1036 Standard Specification for Flat Glass specifications and selected for mirrors. The mirrors are manufactured in accordance with ASTM C1503 Standard Specification for Silvered Flat Glass Mirror.

THIS LIMITED EXPRESS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, INCLUDING, BUT NO LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE AND ANY OTHER WARRANTY OBLIGATION ON THE PART OF THE SELLER. IN NO EVENT WILL SELLER BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL, SPECIAL OR INDIRECT LOSSES OR DAMAGES, ARISING OUT OF OR IN CONNECTION WITH THE PRODUCTS. SUCH EXCLUDED LOSSES AND ITEMS INCLUDE, WITHOUT LIMITATION, COSTS OF REMOVAL AND REINSTALLATION OF ANY PRODUCT OR COMPONENT, LOSS OF GOODWILL, LOST PROFITS, DELAY AND LOSS OF USE. SELLER'S LIABILITY ON ANY CLAIM OF ANY KIND FOR ANY LOSS OR DAMAGE SHALL IN NO CASE EXCEED THE PURCHASE PRICE OF THE PRODUCT WHICH GIVES RISE TO THE CLAIM. SELLER SHALL NOT BE LIABLE FOR PENALTIES OF ANY KIND.
